

ORDINANCE NO. 140 GO

AN ORDINANCE RELATING TO ANNUL, VACATE OR DISCONTINUE CERTAIN STREETS LOCATED IN THE FIRST ADDITION OF THE CITY OF GRAINFIELD, KANSAS AND REPEALING ORDINANCE NO. 125 GO, PURSUANT TO K.S.A. 15-427.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GRAINFIELD, KANSAS, while meeting in regular session and with a quorum present, that:

SECTION 1: The following streets in the First Addition of the City of Grainfield, Kansas, are hereby annulled and vacated with said vacated streets to revert to the owners of real estate adjacent on each side in proportion to the frontage of such real estate to-wit:


Cleveland Avenue from the north side of Front Street north to a line 40 feet south of the north city limits of the First Addition to the City of Grainfield, Kansas is hereby vacated in the City of Grainfield, Kansas. Real estate involved to-wit: block 41 lots 9 thru 16, block 42 lots 9 thru 16, block 43 lots 9 thru 16, block 44 lots 12 thru 22, block 45 lots 1 thru 8, block 46 lots 1 thru 8, block 47 lots 1 thru 8 and block 48 lots 1 thru 10.

Fourth Street between Garfield Avenue and Cleveland Avenue is hereby vacated in the City of Grainfield, Kansas. Real estate involved to-wit: block 42 lots 8 and 9 and block 43 lots 1 and 16.

SECTION 2: The City reserves such right of ways and easements in and to the vacated streets for the purpose of sewer and water improvements with the right of ingress and egress for the purpose of construction, re-construction, and maintenance of said sewer and water improvements.

SECTION 3: This ordinance shall repeal Ordinance Number 125 GO and shall take effect and be in full force from and after passage, approval and publication one time in the official city newspaper.
